AN ORDINANCE AMENDING THE ZONING DISTRICT MAP OF THE CITY OF LARAMIE, WYOMING, BY REZONING APPROXIMATELY 2.39 ACRES OF LAND LOCATED AT 1532 CRYSTAL COURT FROM LM (LIMITED MANUFACTURING)/APO (AQUIFER PROTECTION OVERLAY) / TTO (TURNER TRACT OVERLAY) DISTRICT TO B1 (LIMITED BUSINESS)/APO/TTO.

WHEREAS, on May 21, the Coffey Engineering and Surveying, on behalf of Cornerstone Associates, LLC, filed with the City an application to rezone approximately 2.39 acres of land located at 1532 Crystal Court from LM (Limited Manufacturing)/APO (Aquifer Protection Overlay)/TTO (Turner Tract Overlay) District to B1 (Limited Business)/APO/TTO; and

WHEREAS, on June 10, 2013 City staff presented the rezoning application to the Planning Commission with a recommendation to recommend the City Council approve the proposed amendment; and

WHEREAS, on June 10, 2013 the City Planning Commission reviewed the rezoning application and by majority vote of its members recommended approval of the rezoning the subject property; and

WHEREAS, notice of a public hearing in compliance with Wyo. Stat. §15-1-602(b) by publishing the required notice in the *Laramie Boomerang* on July 7, 2013 which notice was given at least fifteen (15) days prior to the public hearing; and

WHEREAS, the Laramie City Council held a public hearing on July 23, 2013 to take and consider public comments;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LARAMIE:

Section 1. That the foregoing recitals are incorporated in and made a part of this Ordinance by this reference.

Section 2. That the Zoning District Map of City is hereby amended by rezoning the subject property from LM/APO/TTO District to B1/APO/TTO, which is described as follows:

LOT 7, BLOCK 2, TURNER TRACT ADDITION


Section 3. That the foregoing described property contains 2.39 acres more or less, together with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, and all improvements thereon.

Section 4. That this ordinance shall become effective after its passage, approval and publication.
